Maintain the existing boundary fences in a satisfactory and stockproof repair and condition."

- 5 (08.01.1996) The land is subject to the following rights reserved by the Conveyance dated 14 December 1995 referred to above:-

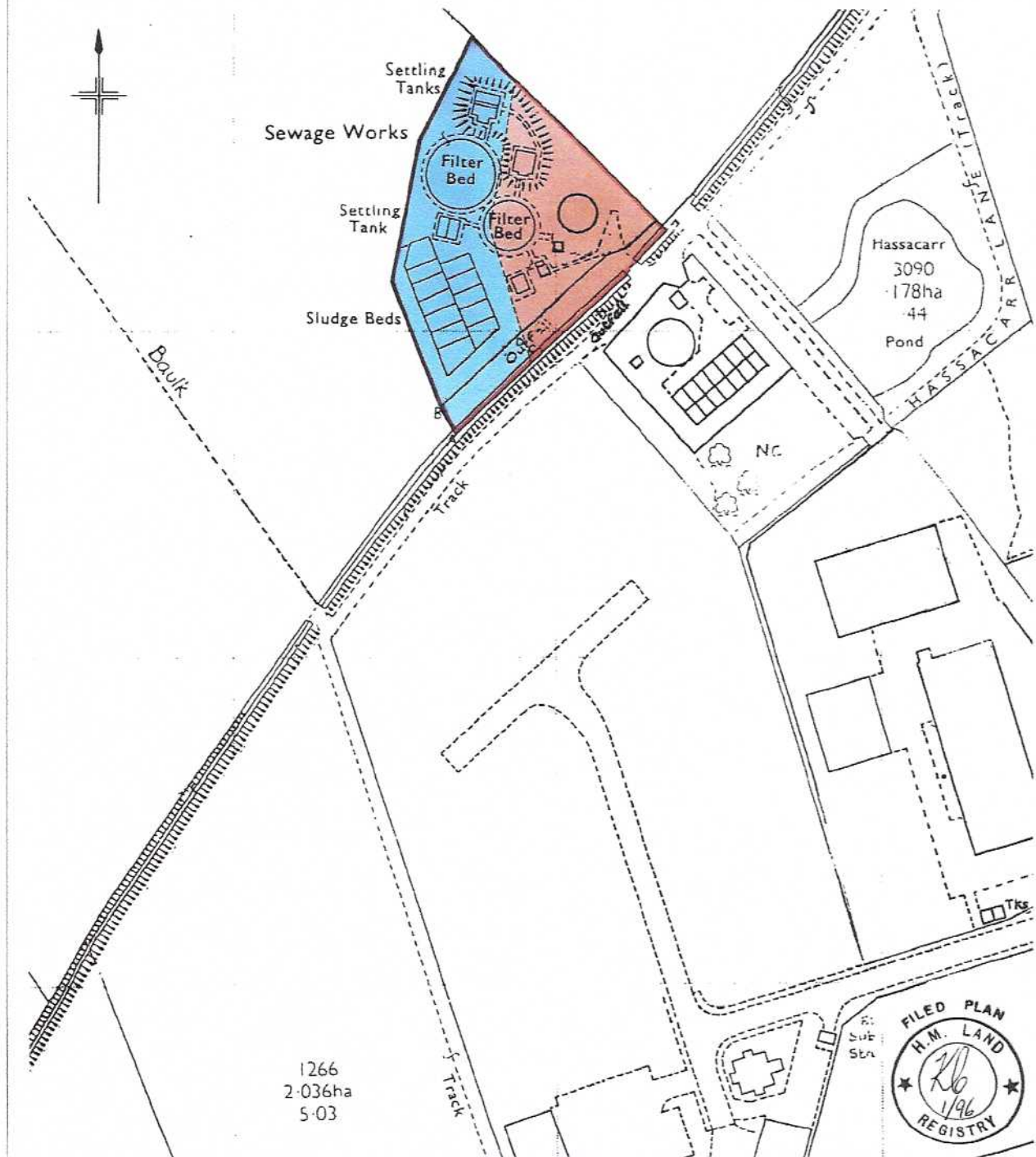

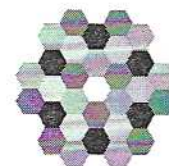
