Thank you for your recent correspondence regarding this title.


The extent originally mapped was based on the apparent occupied extent as revealed by the Ordnance Survey map detail for the area.

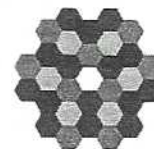

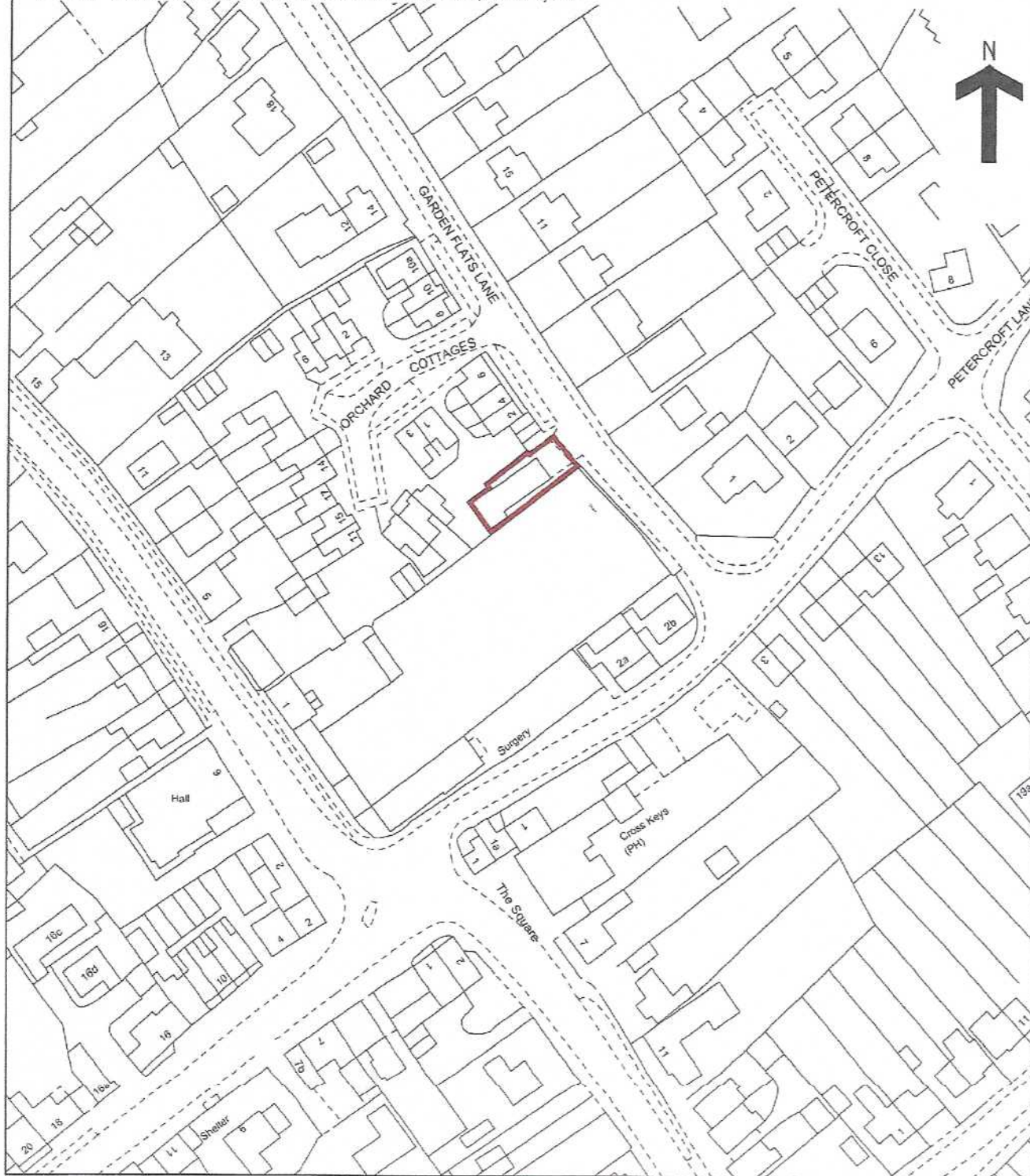

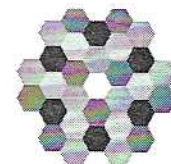
